

INTELLEDOX Infiniti - End User License Agreement (EULA) on premise

INTELLEDOX LICENCE AGREEMENT "The Agreement"

This is a legal Agreement between you (the 'Customer') and Intelledox Pty Ltd (Intelledox). By installing the Intelledox software, you agree to be bound by the terms of this agreement. If you do not agree to be bound by the terms of this agreement, return the software and any accompanying items to the place of purchase.

Grant and Basis of License: Intelledox grants the Customer a non-exclusive, non-transferable perpetual license to the material enclosed, subject to the terms of this document. The Customer is responsible for selection of the software as suitable for its need. Licencing is on the basis of the number of users and details specified in the current license sheet.

Intellectual Property Rights: All copyright, patent, trade secrets and other intellectual property rights to the licenced material are the property of Intelledox and no title is transferred by this agreement. The Customer is to retain the copyright notice and other legends on all copies, both full and partial, of the licensed material. The Customer agrees not to distribute the licensed material or any part of it to any third party, or to copy, modify, reverse-engineer, de-compile or disassemble the licenced material, or to use it in any unauthorised manner except as expressly permitted in writing by Intelledox.

Permission to Copy: The Customer may produce sufficient copies of the licenced material for safe usage of it but may not produce or distribute copies for any other purpose.

Terms of Agreement: This agreement is accepted by the Customer on installation of the software. The Customer may terminate this agreement without notice. Intelledox may terminate it for good cause (including breach of contract and failure to pay licence fees), upon 30 days notice. The Customer agrees to cease using the licenced material and destroy or return it upon termination.

Warranty: Intelledox warrants that the licenced material as supplied by Intelledox complies with its published specifications and is free from defects for 90 days from the commencement of this agreement. Intelledox will undertake its best efforts to correct any defects advised to it during that period. Support and other services after expiration of the warranty period are provided under the provisions of Intelledox's Support and Maintenance Agreement.

Disclaimer: To the maximum extent permitted by law, Intelledox disclaims all further implied or other warranties, including but not limited to warranties of merchantability, fitness for a particular purpose, and non-infringement.

Export Control: The licenced material may be subject to export control legislation in certain countries. The Customer shall not export or re-export the licenced material from the country in which the licence is granted in contravention of any such export control legislation at the time.

Limitation of Liability: Intelledox Software's entire liability and the Customer's entire remedy shall be, at Intelledox Software's discretion, either return of the price paid or replacement of the licensed material which does not meet Intelledox Software's warranty and which is returned to Intelledox Software with a copy of the Customer's receipt.

No Liability for Damages: In no event shall Intelledox or its suppliers be liable for any consequential, incidental, direct, indirect, special, punitive or other damages whatsoever (including but not limited to damages for loss of business profits, business interruption, loss of business information, or

any other pecuniary loss) arising out of the use of or inability to use the licenced material, even if Intelledox has been advised of the possibility of such damages.

Entire Agreement: These terms and conditions supersede all prior oral or written agreements and constitute the entire agreement between them relating to the licence of the material covered by this agreement. There are no understandings or representations, expressed or implied, not expressly set out herein. **Applicable Law:** This agreement is governed by the laws of the Australian Capital Territory.
